DATA DICTIONARY - AUDITOR ENGAGEMENTS

Overview

The auditor engagements data set has one row per SEC registrant that is matched based on a proprietary algorithm to the current auditor of record according to the most recent “Engaged Auditor Date” (Auditor Changes), “Signature Date” (Audit Opinions) and “Year Ended” (Auditor Fees).

Data Field Definitions

The following field names are in bold for the name as it appears on our web site downloads; the field names as they appear in our data feeds are in italics.

Registrant General Information

Company

name

Registrant's current name as filed with the SEC. Programmatically extracted and matched from the sec.gov's registrant header page.

CIK Code

company_fkey

Edgar's Central Index Key. Unique numeric identifier for each registrant. Programmatically extracted and matched from the sec.gov's registrant header page.

Ticker

ticker

Registrant's current stock ticker symbol as of the most recent business day. Programmatically extracted and matched from a third party data provider.

Market

market

Principal exchange the registrant's stock currently trades on. Programmatically extracted and matched from a third party data provider.

IRS Number

irs_number

IRS employer identification number (EIN) disclosed in the registrant's most current periodic report.

Parent CIK

parent_company_fkey

The CIK Code of the parent company, if the registrant is the subsidiary of another SEC registrant. Assigned by internal researchers.

Parent Name

parent_company_name

The name of the parent company, if the registrant is the subsidiary of another SEC registrant. Assigned by internal researchers.

Bus Street 1

bus_street_1

Current business address information. Programmatically extracted and matched from the sec.gov's registrant header page.

Bus Street 2

bus_street_2

Current business address information. Programmatically extracted and matched from the sec.gov's registrant header page.

Current business address information. Programmatically extracted and matched from the sec.gov's registrant header page..

State Code

bus_state

Current business address information. Programmatically extracted and matched from the sec.gov's registrant header page.

Current business address information. Translation of state code field.

State Region

bus_state_region

Current business address information. Translation of state code field to geographic region.

SIC Code

sic_code_fkey

4 digit SIC industry code. Programmatically extracted and matched from the sec.gov's registrant header page.

SIC Description

sic_code_description

Translation of SIC Code.

NAICS Code

naics_code_fkey

6 digit NAICS industry code. Assigned by internal researchers.

NAICS Description

naics_code_description

Translation of NAICS Code.

Fiscal YE

fiscaly_je

The current month-day year year end for the registrant. Programmatically extracted and matched from the sec.gov's registrant header page. Please note that the following variable "may not" represent the actual year end as it comes from the registrant's header and sometimes is not maintained correctly by the registrant.

Auditor Information

Auditor Name

auditor_name

Name of the auditor who (corresponding to the logic indicated in the “Overview” section above) is the auditor of record for the company.

Auditor Key

auditor_fkey

Unique numeric identifier for each auditor.

Activity Year

company_auditor_date_num

Year field based on the most recent date of auditor activity used to name the current auditor.

Activity

change_or_audit_or_opinion

The type of auditor activity related to the registrant: “Engagement” – indicates the auditor of record match was based on data from the Auditor Change data set; “Opinion” – indicates the auditor of record match was based on data from the “Audit Opinion” data set; “Audit” – indicates the auditor of record match was based on data from the “Auditor Fees” data set.

Auditor Since Year

curr_auditor_since_event_date

Year that the auditor was first engaged or earliest known engagement. The auditor since data comes from either our historical auditor databases (ie auditor changes) or from directly inquiring with the public registrants.

Auditor Since Code

curr_auditor_since_event_type

Qualifier field for “Auditor Since Year”. The field can come with two values “Since” or “Since at Least”. “Since” indicates that the auditor was first engaged in the year given in “Auditor Since Year” and has been the auditor since then. “Since at Least” indicates that the auditor has been engaged since the year given in “Auditor Since Year” however we have not confirmed that this was the first year of engagement.

Additional Registrant Information

Last Report

most_recent_periodic_filing_form_fkey

The registrant's most recent periodic report filing. A periodic report would include any of the following form types: 10-K, 10-Q, 10KSB, 10QSB, 20-F, 40-F, 485APOS, 485BPOS, N-CSR and N-SAR.

Last Report Date

most_recent_periodic_filing_file_date

Date the most recent periodic report was filed.

Accelerated Filer

is_accelerated_filer

Indicates whether the registrant has identified themselves as an accelerated filer. See Securities and Exchange Act of 1934 § 240.12b-2 for additional information.

Accelerated Filer Period Ending

accelerated_filer_period_ended_date_num

Period ended date for which the "Accelerated Filer Source" corresponds – generally either the end of a fiscal year or quarter.

Accelerated Filer Source

accelerated_filer_form_fkey

Most recent filing analyzed which contained information regarding the registrant's accelerated filer status.

Accelerated Filer Source Date

accelerated_filer_file_date

Date the "Accelerated Filer Source" was filed.

Last Securities Registration

most_recent_registration_form_fkey

The registrant's most recent securities registration filing. A securities registration would include any of the following form types: S-1, S-3, S-4, S-6, S-8, S-11, S-20, SB-1, SB-2, F-1, F-3, F-4, F-6, F-7, F-8, F-9, F-10, F-80, N-1, N-2, N-3, N-4, N-5, N-6.

Last Securities Registration Date

most_recent_registration_file_date

Date the "Last Securities Registration" was filed.

Deregistration Status

termination_status

Indicates whether the registrant has formally de-registered with the SEC. We indicate the cause when possible.

Deregistration Form

termination_form_fkey

Form type the registrant filed to de-register with the SEC.

Deregistration Date

termination_file_date

Date the "Deregistration Form" was filed with the SEC.

Last Non-Timely Filing

most_recent_non_timely_filer_form_fkey

The registrant's most recent NT- filing form type.

Last Non-Timely Filing Date

most_recent_non_timely_filer_file_date

Date the "Last Non-Timely Filing" was filed with the SEC.

Registrant Financial Information

Financial Data

The financial data points are matched as of the most recent (MR) data on record for each registrant and for the most recent fiscal year (MRFY) end. Please note that when the “Financials Date” field is null or zero, it signifies that we were unable to match corresponding financial information to the data row in question.

MR Stock Price

_7share_price

Closing price of the registrant’s equity on the date specified (see field Stock Price Date). This value is used to calculate the year end market capitalization.

MR Stock Price Date

_7price_date_time

Corresponding date for the Stock Price field.

MR Market Cap

_7market_cap

Market capitalization as of Stock Price Date. Calculated by multiplying total shares outstanding as of Stock Price Date times Stock Price.

MR Financials Date

_7ttm_rev_date_time

Corresponding year ended date for the Revenue, Earnings, Book Value and Assets fields.

MR Revenue

_7ttm_revenue

Corresponds to the past year’s Total Revenue usually found as the first item on the Income Statement. Note that for banks and financial institutions revenue includes both interest and non-interest income. In addition banks and financial institutions do not include write downs or losses of any kind when calculating Total Revenue.

MR Earnings

_7earnings

Corresponds to the past year’s Net Income and is a calculated field (Revenues – Expenses) usually found as a line item on the Income Statement.

MR Book Value

_7book_value

Corresponds to the year end Book Value and is a calculated field (Total Stockholders’ Equity – Goodwill – Intangible Assets).

MR Total Assets

_7assets

Corresponds to the year end Total Assets and is usually found as an item on the Balance Sheet.

MR Shares Outstanding

_7shares_outstanding

Corresponds to the total number of shares outstanding for the registrant.

MRFY Stock Price

latestfy_price_close

Closing price of the registrant's equity on the date specified (see field Stock Price Date). This value is used to calculate the year end market capitalization.

MRFY Stock Price Date

latestfy_price_date

Corresponding date for the Stock Price field.

MR Market Cap

latestfy_total_shares_outstanding_market_cap

Market capitalization as of Stock Price Date. Calculated by multiplying total shares outstanding as of Stock Price Date times Stock Price.

MRFY Financials Date

latestfy_date_ttm

Corresponding year ended date for the Revenue, Earnings, Book Value and Assets fields.

MRFY Revenue

latestfy_incmst_revenue_ttm

Corresponds to the past year's Total Revenue usually found as the first item on the Income Statement. Note that for banks and financial institutions revenue includes both interest and non-interest income. In addition banks and financial institutions do not include write downs or losses of any kind when calculating Total Revenue.

MRFY Earnings

latestfy_incmst_net_income_ttm

Corresponds to the past year's Net Income and is a calculated field (Revenues – Expenses) usually found as a line item on the Income Statement.

MRFY Book Value

latestfy_balsh_book_value

Corresponds to the year end Book Value and is a calculated field (Total Stockholders' Equity – Goodwill – Intangible Assets).

MRFY Total Assets

latestfy_balsh_total_assets

Corresponds to the year end Total Assets and is usually found as an item on the Balance Sheet.

MRFY Shares Outstanding

latestfy_total_shares_outstanding

Corresponds to the total number of shares outstanding for the registrant.

Registrant Financial Information *(continued)*

Float

_3LatestFloat

Corresponds to the total number of shares not held by affiliates of the company.

Short Interest

_3LatestShortInterestShares

Corresponds to the most recently reported total number of shares sold short.

Audit Fees Year

latest_fees_fiscal_year

Indicates the latest fiscal year to which the following auditor fee fields correspond.

Audit Fees

latest_audit_fees_sum

Total audit fees paid during the Audit Fees Year. If more than one firm was paid during the fiscal year, this field shows the sum of all audit fees paid.

Non-Audit Fees

latest_non_audit_fees_sum

Total non audit fees paid during the Audit Fees Year. If more than one firm was paid during the fiscal year, this field shows the sum of all non audit fees paid.

Total Fees

latest_total_fees_sum

Total auditor fees paid during the Fees Fiscal Year Ended. If more than one firm was paid during the fiscal year, this field shows the sum of all fees paid.
